Chief Executive's Notes

LOOKING FORWARD TO A BRIGHTER 2022

As I reflect the year 2021, it is like a mixed blessing. The first half of 2021 was full of challenges and uncertainties, which were unimaginable. Due to the Covid-19 pandemic, the country's economy, businesses and people suffered the worst. Some lost their loved ones while others their jobs, companies closed permanently, hospitals overcrowded with patients and even the political system was unstable.

However, the second half of 2021 showed improvement as Covid-19 infectivity rate declined with almost 100% of the adult population vaccinated which lifted the MCO restrictions, the country took off for a better start. With renewed confidence and hope, many economies and social sectors began to operate. One of the sectors that benefited the most was the plantation sector especially oil palm with unusually high CPO price reaching more than RM5 000 per tonne. Obviously, health products and services too registered fair returns and prospects. Unfortunately, just before Christmas the flood hit all around Malaysia affecting many lives, shelters and livelihoods. Thankfully, many kind and generous Malaysians sacrificed their year end holiday and time to help those who were badly affected by the floods.

As for ISP and ISPM, it was a difficult and challenging year. We too were affected by the Covid pandemic and sluggish economy to a larger extent. In terms of membership subscription, we were able to collect only 56% of subscriptions, which is lower compared to the previous years. Since ISP is a membership driven company, we hope members will pay their annual subscriptions on time. Certainly, more needs to be done to recruit, retain and reward members.

In terms of financial performance, ISP registered surplus for 2021 with prudent financial management. However, ISPM was badly affected by the pandemic, lockdowns and weak economy. As the business arm of ISP, it was under pressure to produce good

financial results. *The Planter* magazine was produced on time even though it was affected briefly due to MCO restrictions. As part of the mitigation process, *e-Planter* was sent to members effective May issue. Overall, the publication unit performed financially well despite the ongoing challenges.

Training and Seminar activities were severely affected in 2021. NATSEM 2021 which was to be held in November 2021 in Miri, Sarawak was postponed to 14 - 15 March 2022 in Kuala Lumpur due to rising Covid-19 cases.

As for short courses, we were unable to conduct physical courses due to MCO restrictions and strict social distancing SOPs. However, we still managed to do quite a number of online courses locally and also collaborated with an overseas partner in Philippines, which generated reasonable income. The number of candidates who registered for March and October 2021 LISP/AISP exams was not encouraging despite our promotional activities. It is a discouraging trend which needs to be arrested with the support of members and plantation companies.

Since we are expecting 2022 to be a better year, the latest Omicron variant and inflation are casting doubts on the projections and prospects in 2022. We hope, the pandemic will end eventually and year 2022 will be a good year for all of us.

ISP and ISPM Board have outlined many goals, programmes and activities for year 2022 covering financial aspects, membership subscription, NATSEM 2022 and Planters' Act. The Secretariat with the cooperation and support of BODs, Standing Committee members, Branch Chairmen and members will strive hard to achieve its targets. I would like to thank BODs, Standing Committee, Branch Chairmen and members, for your invaluable guidance, cooperation and support.

Happy New Year & I wish everyone a great year in 2022.

A visit to Institut Latihan FELDA




