THE SOCIETY REPRESENTS the Planters of Malaysia and other territories, whose personal and professional interests it is bound to endeavour to secure and promote.

OBJECTS foremost in the Society' Memorandum of Association are:

- To promote the general interests of the planting profession.
- To promote the advancement and facilitate the acquisition of that knowledge which constitutes the professional qualification of planter.
- To watch over, promote and protect the mutual and individual interests of its members in respect of matters pertaining to or arising from their employment in the planting profession.
- To promote and maintain good feeling, co-operation and understanding between members and their employers.

MEMBERSHIP OF THE SOCIETY IS OPEN TO:

- **Category A.** Those who owns land with area exceeding 40 hectares and is directly involved in developing the said land, directly employed in plantation management such as visiting agents, estate managers, assistant managers, superintendents, cadets or analogous thereto, and
- **Category B.** Engineers, estate medical officers, qualified scientific or administrative staff of estates or organisations and involved in the management, sales and marketing of chemicals, fertilisers and machinery mainly concerned with the planting industry, which includes those employed in such other senior executive, administrative, professional or advisory capacities as may be deemed by the Board as being equivalent thereto.

Clerks, conductors, hospital assistants, field supervisors etc., are not included in either Category and therefore not eligible for membership.

The Society publishes a monthly journal, *The Planter*, and all paid-up members receive this free of charge.

The Society also conducts examinations under the Technical Education Scheme, organises symposia and seminars and publishes authoritative works on tropical crops.
