Welcoming 2025 with Renewed Commitment and Dedication

The Incorporated Society of Planters has ushered in 2025 with great anticipation and excitement as we have lined up some interesting and impactful as well as collaborative activities for the year. We ended 2024 with healthy financials and a hugely successful NATSEM 2024 held in Miri, Sarawak with better-than-expected turnout, and with some registering their interests to be members of ISP.

In view of the global and national focus on sustainable living through Environmental, Social and Governance (ESG) principles, we have aptly themed this year's NATSEM 25: From plantation to preservation The Role of Palm Oil in Sustainable Vegetable Oil Production. The NATSEM 2025 Taskforce and secretariat



of ISP are now busy preparing for this timely Seminar to be held from 14 to 16 July 2025 at Berjaya Waterfront Hotel, Johor Bahru. We warmly welcome our members and non-members to participate and take advantage of the early bird discounted fee.

The main revenue source for ISP remains membership fee and we urge our members to help us ramp up our recruitment and boost our coffers. We are also confident that those who have not settled their annual fees will do so at their earliest opportunity. In the first quarter of this year, we have managed to attract about 50 members, which is still a long way from our target of 30 a month. It will greatly help us to do more for our existing members. The rejoining fee is RM100 that covers administrative costs while membership fee remains at a very affordable RM200 yearly which comes with many benefits and privileges. We have made it very convenient for members to make payments digitally or in-person.

The Secretariat take this opportunity to encourage our branches to continue to be active and scale up their programmes to attract new recruits in order to remain relevant. Challenges remain in recruiting young and retired ex planters, and retaining them. There is no doubt some branches have remained very active and this is a source of great pride for the HQ to witness these. We need to emphasise that these activities not only elevate our profile, it also puts ISP on the national and international map and serves as an avenue to attract new members, boosting our image further. Keep up the good work!

ISPM also generates income via its numerous training programmes which include technical and management programmes. The response has been nothing short of encouraging boosted by the fact we are collaborating with other parties in training programmes. In order to enhance the skills and knowledge of planters, ISP conducts the LISP and AISP exams at our centres located at ISP HQ, Petaling Jaya, Rompin, Sibu and Lahad Datu.
